Product life	12 months from production date if storage conditions are correct and unbroken <-18°C.
Usage instructions	Defrost inside plastic bag at room temperature for approximately one hour. Once defrosted do not re-freeze.

White flour 58.43% (**wheat** flour, calcium carbonate, iron, niacin, thiamin), Water, Dextrose, **Sesame** seeds, Extra Virgin Rapeseed Oil, Salt (Salt, anti-caking agent: E535), Frozen yeast (bakers yeast, rehydrating agent: E491), **Gluten**, Dough conditioner (**wheat** flour, emulsifier E472(e), flour treatment agent E300).
