Preparation	Dough prepared to exact recipe, baked, chilled and blast frozen at <-26°C and then packed in temperature controlled packing area (<+15°C).
Packaging	Packed in food safe polythene bag/liner and cardboard box, sealed and labelled. Batch coded with best before date and date of production printed on label. Box size 60l x 24l x 280mm Box weight 389g Bag weight 17g Cases per layer/pallet 8/48 Label wrapped around one end and side of box.
Product life	12 months from production date if storage conditions are correct and unbroken <-18°C.
Usage instructions	Defrost inside plastic bag at room temperature for approximately one hour. Once defrosted do not re-freeze.
Quality control standards	Total traceability maintained, quality checks undertaken to the current BRC Global Standard for Food. This product and its constituent parts, meets all relevant UK and EU Regulations and to the best of our knowledge is made from GM free ingredients.

White flour (**wheat** flour, calcium, iron, niacin, thiamin), Water, Sliced black olives 4% (black olives (stones may be present), water, salt, lactic acid, ferrous gluconate), Tomatoes sun dried 4%, Frozen yeast (bakers' yeast, rehydrating agent: E491), Salt (Salt, anti-caking agent: E535), **Gluten**, Dough Conditioner (**wheat** flour, flour treatment agent E300), **Barley** malt flour.
